A RESOLUTION AUTHORIZING THE COUNTY MAYOR TO EXECUTE AN AGREEMENT WITH SEVIER COUNTY TO PROVIDE DETENTION SERVICES FOR JUVENILES ORDERED INTO CUSTODY BY THE GREENE COUNTY JUVENILE COURT

WHEREAS, Greene County recognizes the need and requirement for housing juveniles who are in custody pursuant to the Orders of Courts in Greene County; and

WHEREAS, Greene County must provide these detained juveniles (children) with food, shelter, and such other physical necessities as is required while in custody; Greene County must also provide other services to these children who are in custody including but not limited to educational, medical, etc.; and

WHEREAS, Greene County does not have a juvenile detention center for children and pursuant to the provisions of T.C.A. § 37-1-116(f) Greene County may contract with another facility to provide these services; and

WHEREAS, Sevier County has available bed space, staff, and the resources to house, feed, educate and provide for juveniles from Greene County detained pursuant to the Orders of the Court and Sevier County has agreed to accept said juveniles on an as needed basis; and

WHEREAS, Greene County will pay \$125.00 per child for each twenty-four (24) hour period or part thereof that the child is in custody at the Sevier County Facility; Greene County will also provide transportation and routine and emergency medical, dental, or eye care for those children in detention.

NOW, THEREFORE, BE IT RESOLVED, by the Greene County Legislative Body meeting in regular session on the 17th day of August, 2015, a quorum being present and a majority voting in the affirmative, to authorize the County Mayor to sign any and all documents, contracts, assurances, and forms of compliance necessary to effectuate a contract with Sevier County to provide Juvenile Detention services for children ordered detained by the Courts in Greene County.
