Review of Audit Findings and Recommendations
For the Year Ended June 30, 2011

A review of our findings and recommendations as a result of our audit of the office of Register of Deeds is presented below.

## FINDING 11.01 MULTIPLE EMPLOYEES OPERATED FROM THE SAME CASH DRAWER

(Internal Control – Significant Deficiency Under Government Auditing Standards)

Multiple employees operated from the same cash drawer in the Office of Register. Good internal controls dictate that each employee have their own cash drawer, start the day with a standard fixed amount of cash, and remove all but that beginning amount at the end of the day. This amount should be verified to the employee's receipts at the end of each day. Failure to adhere to this control regimen greatly increases the risk that a cash shortage may not be detected in a timely manner. Furthermore, in the event of a cash shortage, the register would not be able to determine who was responsible for the shortage because multiple employees were working from one cash drawer. This deficiency has been a management decision by the officials resulting in a loss of control over assets. After we brought this deficiency to her attention, the register obtained a separate cash drawer for herself and each employee.

### RECOMMENDATION

The register should ensure that each employee operates from their own cash drawer.

# RESOLUTION AUTHORIZING INCREASE OF REVENUES FOR THE HIGHWAY FUND

WHEREAS, the Greene County Highway budget each year must equal the prior 5 year average revenues received from local revenues in order to assure the maximum receipt of gas tax revenues from the State, and

WHEREAS, during the preparation of the certification of Greene County Highway for the fiscal year 2011-2012 it was noted that the 5 year average exceeded the amount budgeted for the FYE 2011-2012, and

WHEREAS, the Greene County Budgets and Accounts Director has reviewed the revenues budgeted for the Highway Fund and has determined that revenues for certain line items have been underestimated during the budget process and

## RESOLUTION TO ASK THE GENERAL ASSEMBLY TO MAKE THE SALE OF SYNTHETIC DRUGS A FELONY

WHEREAS, synthetic marijuana and designer stimulants have created a public health problem in some counties across the State of Tennessee; and

WHEREAS, currently within the State of Tennessee some of these synthetic products are sold legally, while the sale of other synthetic drugs are covered by misdemeanor criminal statutes making the sale of those drugs a misdemeanor punishable only by a fine of Fifty Dollars (\$50.00); and

WHEREAS, the problems and issues with the sale of these synthetic drugs are an increasing concern for the law abiding citizens of Greene County and as such the Greene County Commission is requesting that the General Assembly make the sale of synthetic drugs a felony.

NOW THEREFORE, BE IT RESOLVED, by the Greene County Legislative Body meeting in regular session on the 17th day of January, 2012, a quorum being present, unanimously approve this Resolution requesting that the legislative delegation from Greene County sponsor and support legislation making the manufacture, distribution and sale of synthetic drugs a felony in the State of Tennessee.

WHEREAS, some nine years ago Greene County and the State of Tennessee Department of Safety entered into a contract which provided for Greene County to build a drivers license center on property owned by Greene County on Hal Henard Road, which facility after construction was leased to the State of Tennessee to operate a drivers license center as well as offices for highway patrol officers; and

WHEREAS, for the past years the drivers license center has offered services to the citizens and residents of Greene County, that would allow those citizens and residents to secure learners permits, drivers licenses, renew drivers licenses, gun permits, and drivers records; and

WHEREAS, recently it was announced that the Department of Safety would be reducing operations at the drivers license center on the Hal Henard Road with only reinstatement of drivers licenses being handled at that facility; and

WHEREAS, the practical effect would be that any individuals seeking learners permits, drivers license or renewals of drivers license, gun permits, and driving records would be required to travel to one of the adjoining counties that continues to offer those services; and

WHEREAS, after carefully considering this issue and the inconvenience that reduced services at the drivers license center will offer it would be in the best interest of the citizens and residents of Greene County for the County Commission to formally request that the Governor and or the Department of Safety reconsider the decision to reduce those services offered at the local drivers license center and to permit the drivers license center to perform the services for the citizens of Greeneville and Greene County that have been occurring for the past two decades.

NOW THEREFORE, BE IT RESOLVED, by the Greene County Legislative Body meeting in regular session on the 17th day of January, 2012, a quorum being present, a majority voting in the affirmative that this Resolution requesting that Governor and the Department of Safety along with the members of the General Assembly representing Greene County reconsider the decision to reduce services offered by the local drivers license office located on Hal Henard Road.
