A RESOLUTION OF THE GREENE COUNTY LEGISLATIVE BODY AUTHORIZING SUBMISSION OF AN APPLICATION FOR A LITTER AND TRASH COLLECTION GRANT FROM THE TENNESSEE DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE ACCEPTANCE OF SAID GRANT

WHEREAS, the Greene County Mayor's Office intends to apply for the aforementioned grant, during the 2010-2011 fiscal year, from the Tennessee Department of Transportation; and

Notice is hereby given that your voting location has been changed from the Sunnyside School because the Greene County Board of Education voted no longer to provide needed maintenance and utilities for this old building. Your new location will be at the Sunnyside Volunteer Fire Department.

The Sunnyside Fire Department voted to permit the residents of the 24th district to use their facility on election days as their new voting location. Currently, the Greene County Maintenance Department is working with the Volunteer Fire Department to make the new location a handicapped accessible polling place. Voting at this new place will begin with the upcoming Greene County Primary Election on May 4, 2010. This new site is located at 200 Carmel Hill just off Sunnyside Loop near the old Sunnyside Store building. Signs to the Volunteer Fire Department are provided in the area.

A RESOLUTION TO ACCEPT PARTIAL PAYMENT OF PROPERTY TAXES

WHEREAS, in accordance with T.C.A. 67-5-1801(e)(1) & 67-5-1808, beginning with 2010 tax year, Trustees may accept partial payment of property taxes; and

WHEREAS, Prior to accepting partial payment of property taxes, the trustee must file a plan with the Comptroller of the Treasury; and

WHEREAS, If the Trustee does accept a partial payment of taxes, this action does not release the tax lien, except to the extent of the partial payment; the Trustee has the duty to accept the balance as if no partial payment has been made; and

WHEREAS, If the Trustee accepts partial payments, the Trustee must accept partial payments from all taxpayers in the county; and

WHEREAS, the Trustee's office will not need any new money to implement this because the software that is currently in use in the Trustee's office is adapted to do this function; and

WHEREAS, Beginning October 1, 2010 with 2010 taxes the Greene County Trustee's Office will allow three payments between October 1 and February 28 within the current tax year with the third payment being payment in full for current year taxes.

NOW, THEREFORE, BE IT RESOLVED, by the Greene County Legislative Body, meeting in regular session, this 15^{th} day of March, 2010, a quorum being present and the majority voting in the affirmative, that the Greene County Trustee's Office shall begin accepting partial payment of taxes for the 2010 tax year on October 1, 2010 in accordance with T.C.A. 67-5-1801(e)(1) & 67-5-1808 as described above.

Dear Mr. Broyles:

It is my understanding that the Election Commission Office has been requested to verify the following information based on the current information on file on the persons in which a duplicate copy of the resume was sent from the county mayor's office.

These four (4) qualification requirements were supplied to our office by County Mayor Broyles and County Attorney Roger Woolsey.

Qualifications for the Board are contained in T.C.A. 49-2-201 & 202

- 1. Members of the board shall be residents and voters of the county in which they are elected and shall be citizens of recognized integrity, intelligence and ability to administer the duties of the office.
- 2. No member of the County Legislative Body or any other County Official shall be eligible for election as a member of the County Board of Education.
- 3. No person shall be eligible to serve on the Board unless the person is a bona fide resident of the County and has a practical education; additionally no person shall qualify as a candidate for the position on the Board of Education until the person has filed with the County Election Commission proof that the candidate graduated from high school or received a GED, evidenced by a diploma or other documentation satisfactory to the commission.
- 4. Members of the County Board of Education shall be residence of and elected from the districts of substantially equal population established by resolution of the local Legislative Body.

The newly appointed board member will represent the following precincts in the Fourth School Board District:

4 th – McDonald	4 th – Warrensburg	5 th -Orebank
6 th – Mohawk	7 th – Mt. Carmel	8 th – Mt. Pleasant
10-1 High School	10-2 Andrew Johnson	19 th - Midway
23 rd – Mosheim	23 rd – Mosheim Corporation	25 th – Glenwood

Regarding the documentation of educational background, the vacancy appointment being filled by the County Commissioners would be what is satisfactory to the County Commissioners. These documentations provided would be considered evidence that the person being reviewed has met the satisfactory requirements for the Election Commission Board when dealing with petitions for Election Ballots.
