## RESOLUTION TO AMEND THE RULES OF PROCEDURE FOR THE BOARD OF COUNTY COMMISSIONERS THAT WAS PREVIOUSLY ADOPTED ON SEPTEMBER 19, 2011

WHEREAS, the Greene County Board of Commissioners adopted certain Rules of

Procedure on September 19, 2011, to enable the Board (Commission) to conduct its business
in a more efficient and professional manner; detailing the rights and responsibilities as well as
the process upon which members of the Commission, County Elected and Appointed Officials
and others who assist the County Commission should act and perform.

WHEREAS, in order to clarify certain procedural issues, Rule 17 – Committees needs to be amended by adding Rule 17G. as follows:

7G. For committees, a quorum for the transaction of business shall be a majority of the committee members. The Chairman or committee member acting as Chairman shall have the same rights as other committee members, including the right to vote; however, the Chairman or committee member acting as Chairman may not vote twice in order to break a tie vote. A committee member who is a candidate for a committee office shall abstain from voting in the election in which they are a candidate. However, a candidate who has been eliminated in a prior round may vote in subsequent rounds of voting. Rule 8 – Elections and Appointments shall be followed during this process. A majority of the committee members voting shall be necessary to pass motions, elect officers, etc. Committee members who abstain or "pass" shall not be counted as voting for determining a majority vote.; and

WHEREAS, it would appear that the efficiency and effectiveness of the Board of County Commissioners would be enhanced by amending the Rules of Procedure for the Board by adding Rule 17G.

THEREFORE BE IT RESOLVED, by the Greene County Legislative Body, meeting in regular session on the 15<sup>th</sup> day of October, 2012, a quorum being present and a majority voting in the affirmative, that the Rules of Procedure for the Greene County Commission be amended by adding Rule 17G. as stated above.

# RESOLUTION ENDORSING THE CONTINUATION OF THE GREENEVILLE LIGHT AND POWER SYSTEM'S "OPERATION ROUNDUP", A COMMUNITY ASSISTANCE FUND TO BE USED BY THE GREENEVILLE PARKS AND RECREATION DEPARTMENT'S ADVISORY COMMITTEE FOR CAPITAL IMPROVEMENTS PROJECTS

WHEREAS, Greeneville Light and Power System has been providing electrical service to the citizens of Greeneville and Greene County for over fifty years and has been a corporate leader and innovator in providing much needed community service projects for this community; and

WHEREAS, the Greeneville Light and Power System has established "Operation Roundup", a Community Assistance Program and Fund to be used by the Greeneville Parks and Recreation Department's Advisory Committee for capital improvement projects; and

WHEREAS, "Operation Roundup" has provided and continues to provide an opportunity for customers of Greeneville Light and Power System to support the community by giving an average of just six dollars (\$6.00) a year to improve the quality of life in our community. This project is on a voluntary basis only and the customer has the option to participate if he or she desires. If a customer participated in this program, then the customer's monthly bill will be rounded up to the next whole dollar amount for contribution to the fund. For example; if an electric bill were \$67.63, the bill would be rounded up to \$68.00 even. The additional thirty-seven (37) cents would be placed into the "Operation Roundup" Trust, to be utilized by the Greeneville Parks and Recreation Department's Advisory Committee for capitol improvements; and

WHEREAS, Greene County and the Town of Greeneville has certain recreational and athletic complex facilities operated by the Greeneville Parks and Recreation Department and by the Greene County and Greeneville Boards of Education; and

WHEREAS, in order to assist in securing the necessary funding for infrastructure improvements for lighting at the athletic and recreational complexes, the additional funding
