GREENE COUNTY LEGISLATIVE BODY
MONDAY, JULY 19 2010
6:00 P.M.

The Greene County Legislative Body met in regular session on, Monday, July 19, 2010 at the Greene County Courthouse for the regular monthly meeting of the County Commission. Mayor Broyles called the meeting to order to transact business that is to lawfully come before this Honorable Body. Commissioner Hilton Seay led the Pledge to the Flag, followed by Prayer led by Commissioner Clark Justis. The Commissioners signed in on their key pads and the following Commissioners were present:

Commissioner Riley came in after roll call making 19 present.

APPROVAL OF PRIOR MINUTES

A motion was made by Commissioner Alexander and seconded by Commissioner Brown to approve prior minutes. Mayor Broyles called for the Commissioners to vote on their keypads. The following vote was taken: Commissioners Betty Alexander, Bill Brown, John Carter, John Cox, Bill Dabbs, Margaret Greenway, Brenda Grogan, Rennie Hopson, Clark Justis, Jan Kiker, Phil King, Robert W. The motion to approve the prior minutes was approved by the Commissioners.

PUBLIC HEARING

Mayor Broyles asked that no personal attacks be made by those speaking or they would be called out-of-order. They should state name and reason for speaking and stick to that reason. They would have three minutes to speak.

Mr. Larry Parman spoke to the Commissioners stating that he is against borrowing more money and going into debt more.

Ms. Judith Sexton spoke to the Commissioners asked why our tax dollars are being squandered by department heads and by the airport. She asked the Sheriff if he was reelected would he push for a new jail, would the existing jail be condemned and does he issue vehicles to people who are not employees. The Sheriff answered that he was not pushing for a new jail. Only the Commission can build a jail. He also explained that he only wants to maintain a certified jail. He also noted that he lets other departments and agencies use vehicles that need them.

Ms. Karen Wagner spoke to the Commissioners thanking them for the benefits that the county employees now have and asking that they continue to provide these benefits. She said that she is retiring at the end of September and thanked the Commissioners and especially David Thompson for all they have done saying that David is a great boss and leader. She has worked for the County for 42 years.

Mr. Bill Rader, Sr. spoke saying that he believes that the Sheriff wants a new jail and that prisoners should not have the best.

Ms. Robin Quillen spoke saying she has studied the budget and has gone to several departments and spent some time and that the department heads are working on a shoestring with what they are given and are doing a wonderful job. She invited the citizens to feel free to offer any workable solutions for some of the things that they feel are problems in the county so that we can work together.

A motion was made by Commissioner Robert King and seconded by Commissioner Waddle to approve a resolution authorizing the issuance of not to exceed eight million two hundred twenty-five thousand dollars (\$8,225,000) General Obligation Bonds of Greene County, Tennessee. Mayor Broyles called for the Commissioners to vote on their keypads. A RESOLUTION AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS, IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED EIGHT MILLION TWO HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$8,225,000) OF GREENE COUNTY, TENNESSEE, MAKING PROVISION FOR THE ISSUANCE, SALE AND PAYMENT OF SAID BONDS; ESTABLISHING THE TERMS THEREOF AND THE DISPOSITION OF PROCEEDS THEREFROM, PROVIDING FOR THE LEVY OF TAXES FOR THE PAYMENT OF PRINCIPAL OF, PREMIUM, IF ANY, AND INTEREST ON THE BONDS.
