

ELECTION NOTICE

for the August 1, 2019, Town of Greeneville Municipal Election

To the voters of the Town of Greeneville, you are hereby notified pursuant to TCA 2-12-111(a) and in compliance with the Town of Greeneville's city charter, that a **municipal election** will be held on **Thursday, August 1, 2019**, in all precincts in the Town of Greeneville for the purpose of electing the following offices:

Alderman – 1st Ward (two seats)	2-year term
School Board Member – 1st Ward (two seats)	4-year term
Water Commissioner-at-Large (one seat)	6-year term

Any other office or question that may appear on the ballot

The Election Commission will be closed for all Greene County Government observed holidays excluding Election Day.

- The first day to pick-up a nominating petition is March 18, 2019.
- *Petitions may be picked up at the Greene County Election Commission Office.*
- **Qualifying deadline will be Thursday, May 16, 2019, at 12:00 NOON**
- **The withdrawal deadline will be Thursday, May 23, 2019, at 12:00 NOON.**
- The last day to register to vote in person or by mail postmarked for the August 1, 2019, Town of Greeneville Municipal Election will be **Tuesday, July 2, 2019.**

Public Notice for Elderly Voters or Voters with Disabilities

Any elderly voter or voter with a disability whose polling place is inaccessible may vote early by absentee ballot *or* at the Election Commission Office on Election Day. TCA 2-3-109 (e) (1)

If voters choose to vote at the Election Commission Office on Election Day, they must complete an affidavit at the Election Commission Office **no later than Monday, July 22, 2019**, (*ten days prior to the election*), stating that their designated voting location is not accessible. For more information, please contact the Greene County Election Commission office.

PHOTO ID REQUIRED FOR VOTERS: If you are voting in person during Early Voting or on Election Day, a federal or State of Tennessee Government issued **photo ID** is required for voting unless an exception applies. College student ID's and out-of-state photo ID's will not be accepted. Forms of acceptable identification, even if expired, include a Tennessee driver license with your photo, United States passport, Tennessee Department of Safety and Homeland Security photo ID, Photo ID issued by the federal government, United States military ID including a Veteran Identification Card, and a Tennessee handgun carry permit with your photo.
