GREENE COUNTY LEGISLATIVE BODY  
FEBRUARY 19, 2019

The Greene County Legislative Body was in regular session on February 19, 2019 at 6:00 P.M. in the Greene County Courthouse.

Mayor Morrison called the meeting to order to transact business that has lawfully come before the Honorable Body. Commissioner Jason Cobble gave the invocation. Commissioner Josh Kesterson called the Boy Scout Troop #96 to lead the Pledge to the Flag.

Mayor Morrison called the Commissioners to sign in on their keypads and the following Commissioners were present. Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Tucker, Waddle, and White were present. Commissioner Patterson was absent. There were 20 Commissioners present and 1 absent.

A motion was made by Commissioner Waddle and seconded by Commissioner Quillen to go into closed session to discuss Judge Ash's order to mediation concerning the lawsuit.

Mayor Morrison called the Commissioners to sign in on their keypads. The following vote was taken to approve the minutes. Commissioners Arrowood, Bible, Bowers, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Tucker, Waddle, and White voted yes. Commissioner Bryant voted no. Commissioner Patterson was absent. The vote was 19 – aye; 1 – nay; and 1 - absent. The motion to go into closed session passed.

After the closed session, the Commissioner meeting reconvened at 7:15 P.M.

## PUBLIC HEARING

Joel Hausser spoke to the Commissioners thanking the Greene County Sheriff Wesley Holt and the Sheriff's Department in keeping the safety of the Greene County citizens as their best interest. Mr. Hausser thanked the Greene County Board of Education for the decisions in closing schools due to the inclement weather for the safety of the students. He also thanked Kevin Swatsell, Greene County Road Superintendent, and the Highway Department for a job well done in the clearing of the Greene County roads due to the rainstorm and the high winds.

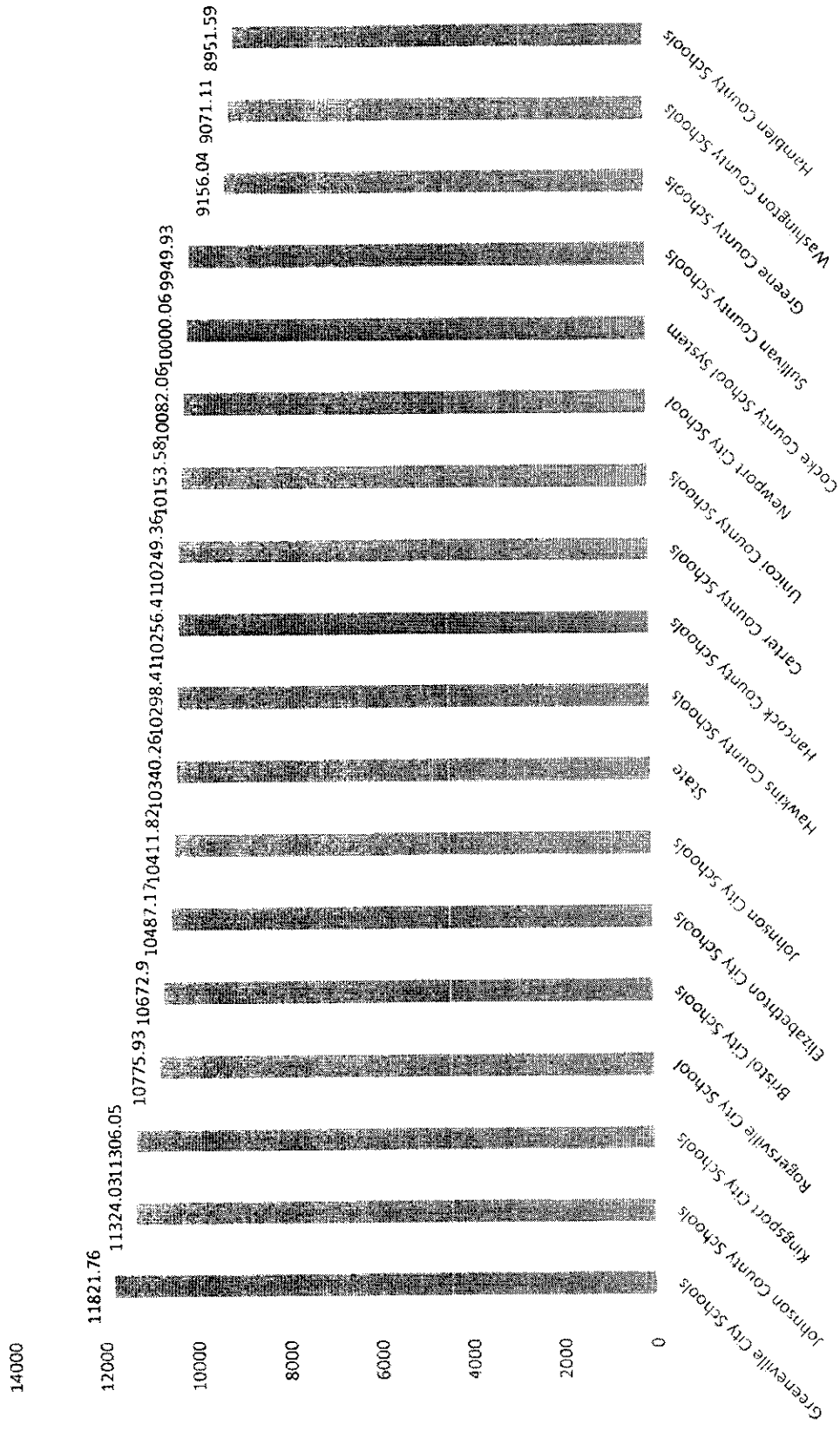

Animal Control Director Chris Cutshall asks for a nomination for a Chairman. A motion to nominate Commissioner Lyle Parton as Chairman was made by Commissioner Jeffrey Bible, it was seconded by Commissioner Teddy Lawing. All agreed. A motion to nominate Commissioner Robin Quillen as secretary was made by Commissioner Jeffery Bible, it was seconded by Commissioner Teddy Lawing. Motion carried.

**CALL TO ORDER:**

Chairman Lyle Parton called the Animal Control committee meeting to order on Wednesday, October 17<sup>th</sup> at 3:00 PM in the conference room at the Annex.

Motion to approve the Animal Control minutes July 18<sup>th</sup>, 2018 was made by Commissioner Bible, seconded by Commissioner Kaleb Powell. Motion passed.

**REPORTS:**

Animal Control Director Chris Cutshall presented the Rabies Control quarterly report for July, August and September. Calls regarding animals totaled 781 which was up about 60 from last quarter. Animal Bite Investigations totaled 33. Five animals were tested in State Lab including a bat. All were negative for rabies. A total of 577 animals were picked up. 274 were rescued, 41 claimed, and 262 were put to sleep. 92 of them had health problems, 106 were aggressive and 64 were adoptable.

Mr. Cutshall stated that the isolation kennel has been set up and ready to go. It was finished yesterday. Working on getting bids for the facility fence. The first issue is getting a bank that has been washed out forming a ditch fixed. Once the whole has been fixed the fence can go there.

Mr. Cutshall informed the new committee members about the Animal Vaccination Fee Fund. The Animal Control Department is collecting \$1.00 for each cat and dog that is vaccinated in Greene County and is set aside to pay for capital expenditures. Animal Control has reimbursed the General Capital Projects Fund for one truck. The account has \$29,264 right now. Resolution authorizing \$65,000 funds for the purchase of two trucks was approved last year. The revenue money collected going into the Vaccination Fee is being used to pay this back. Mr. Cutshall would like to buy one more truck to replace the 2011 model that has \$150,000 miles on it. Once it is replaced, plans are to start building the rabies fund back up to look at fixing things up and maybe adding more kennels. He invited the committee to come down and visit the Shelter any time.

**MEETING ADJOURNED:** Mr. Parton moved to adjourn 3:19 PM. Seconded by Mr. Lawing. Motion carried.

## JAIL/WORKHOUSE/COURTHOUSE COMMITTEE MEETING

The above stated committee met on June 13 at the new classroom facility behind the workhouse. Present were: Commissioners George Clemmer, Lyle Parton, Zak Neas, Frank Waddell, Buddy Randolph, Eddie Jennings and Robin Quillen. Also present were: Cameron Judd with the Greeneville Sun, Jail administrators John Key and Roger Willett and Sheriff Hankins. However, Commissioner Jennings chose to leave the meeting about 10 minutes into it.

David Church, who owns property adjoining the workhouse, has offered to sell us his land for 30K. We went to look at it so that we could discuss it. It was voted to have county attorney look into purchasing it and possibly we will take it before the full commission for a vote. We also looked at a leaking boiler at the workhouse.

A total of 9,600.00 will be moved from the general fund into the jail fund for medical bills. This will be promptly put back into the general fund upon receipt of it from the state.

The committee also briefly discussed the lawsuit brought by several district attorneys against the companies who sell opiates. There are several drug addicted babies born in our area on a regular basis.

The new classroom has received a donation of 7,500.00 toward getting it ready to use and to fund the GED program and the following work programs.

The new software is now completed for the first phase. It is hoped to be able to go online with 911 sometime in July.

It is now time for our yearly jail inspection.

Sheriff Hankins will be traveling to Reno, NV to the National Sheriffs Conference. He hopes to learn more about the new drugs that are popping up in our area.

### **CALL TO ORDER:**

Mayor Morrison called the meeting to order at 3:30 P.M. in the conference room at the Greene County Annex.

### **MINUTES:**

A motion to approve the minutes from October 8, 2018 was made by Commissioner Robin Quillen, seconded by Commissioner Kaleb Powell. Teddy Lawing spoke up and said there was a correction to be made on the minutes. The minutes stated on page 2 that the SROs were not Civil Service, but they are. Correction made on minutes. Vote taken to approve amended minutes. Commissioners Brad Peters and Butch Patterson abstained. All others voted aye to approve. Minutes approved.

### **DISCUSSION:**

Mayor Morrison turned over the meeting to Erin Elmore. She has talked to all department heads about the proposed changes to the Personnel Policies. She gave out a draft of the new policy and also Sick Bank policy and the Inclement Weather Policy that Mayor Morrison has

been working on. She stated all but one department is in agreement to the new policy. This department is not necessarily against the new policy, they just don't want to make any changes. This department gets more holidays and bereavement days. Commissioner Butch Patterson asked how much more. Erin replied that they get 3 extra holidays and 2 extra bereavement days.

Roger Woolsey then explained how departments can have different policies. A department can fall under County Policy or can have their own. Once the policy is approved, it stays approved. The policies in place now were approved many years ago.

Discussion went back and forth on County policy or individual department policy. Commissioner Brad Peters stated that the next time raises are given, it should be anyone following the County Policies only. Commissioner Butch Patterson stated you want to take care of loyal employees. Commissioner Doc Bryant said you need to show the employees the benefits they will gain with the new policy and how it offsets the current policy. Commissioner Robin Quillen stated they will want to get benefits from both policies. Roger Woolsey said it will be up to Payroll to catch and stop (speaking of changes to how vacation/sick time is accrued). Erin Elmore said payroll can't do the accrual manually that it is programmed into the system.

After more discussion back and forth on one County policy vs single department policy, Erin Elmore asked the committee to look at the vacation policy on page 3 of the draft given out. There was much discussion back and forth on how vacation time is accrued for the various departments that work different number of hours each day. Some work 7.5 hours, some 8.0 hours, some 12 hours and some like EMS work 24 hour shifts. Commissioner Doc Bryant suggested that vacation time should be hour based and not day based as it is now. Roger Woolsey stated that they need to look over this policy and make corrections as needed. Said that it needs to be done right one time and be done with it.

Commissioner Butch Patterson left at 4:05pm

When discussion turned to sick time and the sick time bank, Erin Elmore stated that you have to be careful on leave due to FMLA and ADA regulations. She asked what everyone's thoughts were on the sick time bank. Sheriff Holt state he thinks it's a good thing for employees.

Erin Elmore then brought up the Inclement Weather Policy. Commissioner Doc Bryant stated if you have a job, you should be there. Mayor Morrison said the weather policy was taken from what the City uses and he also looked at the State policy. Commission Doc Bryant asked if it was necessary to pay the employees? Mayor Morrison said if they can't make it to work, then they will be using their accrued time. If the offices are closed due to weather, they are still paid though. Mayor Morrison discussed how he came up with the weather policy. Policy needs to be uniform for all departments and enforced. All or none.

Roger Woolsey left at 4:40pm

Discussion then went to previous wage and compensation studies.

Erin Elmore is to work more on the policies discussed.

Teddy Lawing stated that the Inclement Weather Policy should be voted on. Commissioner Doc Bryant asked for more time to look over the policy because he didn't want to vote on it without reading over it better. No votes were taken.


Others in Attendance: Steve Tipton

The Committee reviewed the minutes from the 3 December meeting. Mr. Bowers made the motion to approve the minutes with corrections. Mr. Dabbs seconded. Motion to approve passed 4-0.

Although Director McLain and the Board of Education had no formal actions for the Committee to consider, he did invite Steve Tipton, the County's Energy Education Specialist, to explain the process for accessing low cost loans from the Tennessee Dept of Education's Energy Efficient Schools Initiative (EESI) to resource the replacement of aging HVAC systems throughout the school system. Of 621 HVAC units in Greene County School facilities, 272 are over 20 years old, 254 are 15-16 years old and 95 (at West Greene HS and South Greene HS) have been replaced in the last few years. Mr. Tipton explained the process of Performance Contracting whereby savings accrued from more efficient utility usage would go towards paying off the loans as well as the options for selecting qualified vendors if the Board of Education wants to implement this plan.

Mr. McLain also provided the Committee with updated attendance data from Cooperative Strategies showing out year student projections as well as out-of-district attendance figures.

# Greeneville-Greene County Public Library

## Board Meeting Minutes

January 28, 2019

The Greeneville-Greene County Public Library Board of Directors met for a regularly scheduled quarterly meeting on Monday, January 28, 2019 at 4:00 p.m. in the Big Spring Room of the Main Library.

Board members in attendance were: Barbara Britton, Buddy Hawk, Ginny Kidwell, Butch Patterson and Julia Pensinger. Greeneville-Greene County Public Library Director Erin Evans, Assistant Director Chris Gose along with Holston River Regional Library Director, Whitney Nelson were in attendance. Lindy Riley, President of Friends of the Library was also present.

Chairman Ginny Kidwell called the meeting to order and welcomed guests Stevie Hughes, Candy Cox and local news media, WGRV reporter Reid Seals.

Minutes for the October, 2018 meeting were unanimously approved with minor correction and clarification on motion by Buddy Hawk, seconded by Julia Pensinger. Correction on page 4, second paragraph should read: ...the Society was able to give \$1000 to the Cox Library. Chairman Kidwell had asked Director Evans to report to the Board the correct amount of money the Genealogy Society had contributed to the library during the last two years. In 2017, the Society submitted a check for \$3000 and in 2018 gave \$1000 for the roof, for a total of \$4000.

Library Director Erin Evans discussed the financial report which reflected available funds of \$55,723.71 on January 1, 2019. This is approximately \$10,000 more than this time last year due largely to re-staffing. Expected revenue includes \$49,000 from the county, the

quarterly stipend of \$3000 from Friends of The Library along with additional grant monies. This report stands as presented.

Director Evans gave the Director's report by discussing the circulation statistics and the programming calendar spread sheet. Director Evans felt that her going to Tusculum View Elementary School to promote literacy, has enabled her to build relationships with the students who now know her when they come into our library.

During the crafternoon at the library, participants made Christmas trees from old books and turkeys from old encyclopedias. On February 7, participants will create Valentine wreaths.

Staff participated in Halloween Happenings, giving out 4000 pieces of candy.

The Cox Library report was presented by Assistant Director Chris Gose reporting that attendance was down this quarter, possibly due to holiday closings and snow days. Volunteer hours have been phenomenal which has enabled work to progress on the archival recording system.

Documents have been fully transcribed, over 200 pictures scanned, over 100 items scanned and the system is cloud based. Gose will send out a link to the system when completed for members to peruse.

Board Chair Ginny Kidwell gave her report by stating that the Board needs to begin preparing the strategic, technology and emergency plan. She would like for two board members to work on each plan and she will be a part of each.

Julia Pensinger advised this will be the last year the book sale can be conducted at the location on North Irish Street as the building has been sold and the new owners have asked for the building to be vacated by the end of May. Thus, an urgent need for a free place to store books at the conclusion of this year's sale. Diane Strimer is the facilities acquisition manager.

Under old business, Chair Kidwell reported that the HVAC has been installed and paid for. A hail guard was installed over the front of the unit to prevent debris buildup. The heat is constant at 68 degrees in the upstairs of the library.

Assistant Director Gose reported that Terry Burrell is trying to schedule the roofing between the weather and his other obligations. A check has been given for half of the costs which covered the materials. John Darnell has estimates between \$3200-\$3400 which would cover the material and labor for the outdoor wood railings on the second floor of the Cox Library. Guttering with mesh guard covering is estimated at \$1150. Gose and Evans will get estimates for windows at the Cox Library.

Under new business, Chair Kidwell reported that we now have in place a policy for "Handling Money" received at the library for Friends of the Library, Genealogy Society or any other authorized organization. For patrons who happen to be present in the library and wish to pay their membership to either organization, they can place their dues in a pre-addressed envelope to the appropriate organization and seal it. Library staff will place the envelope with the organization's regular postal mail to be picked up by a representative from that organization. When items are sold at either library on behalf of another organization, sales will be rung up on the cash register and the money collected will be deposited at Town Hall with other library monies. The staff member making the sale will record the sale and pass the information to the Library Director. The Library Director will keep an accounting of sales made during each quarter and request payment to the organization from Town Hall at the end of the quarter. Motion was made by Julia Pensinger and seconded by Butch Patterson to adopt this procedure as policy for the library. Motion was approved unanimously.

Director Evans reported that by Friends of the Library matching the yearly tech grant, this year the library will be able to purchase two children's work stations which are badly needed. Also, Friends of the

Library giving a \$3000 quarterly stipend will help to keep the library operating.

Director Evans reported that the library received a "clean" audit, no findings. Chair Kidwell expressed gratitude to Carol Susong at Town Hall for her help in this endeavor.

Chair Kidwell suggested the name of Ed Ruch for a Holston Regional Library trustee. Motion to nominate Mr. Ruch for this position by Butch Patterson and seconded by Julia Pensinger. Motion passed unanimously. The county commission will consider Mr. Ruch's appointment to the Regional Library Board.

Chair Kidwell reported that members Julia Pensinger and Bobby Holt's terms have expired. She suggested Eleanor G'Fellers, a retired teacher that has expressed deep appreciation for the library and Susan Brandon, also a former teacher and current business woman for consideration. Motion by Butch Patterson and seconded by Julia Pensinger to submit these two names to the governing bodies for appointment. Motion passed unanimously.

Friends of the Library report was given by Lindy Riley who advised they have amended their by-laws to state that a representative of the library board will serve on their board as "ex officio".

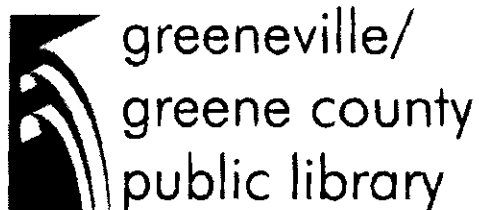

A motion was made by Commissioner Lawing and seconded by Commissioner Peters to approve a Resolution to authorized the exercise by the County of certain powers granted to municipalities under T.C.A. 6-2-201(22) and (23) with respect to the regulation of nuisances and other practices detrimental to the inhabitants of the County.

Greene County Attorney, Roger Woolsey, explained that by adopting this Resolution, Greene County sets in place to exercise certain powers that the Greene County has not been able to exercise in the past to regulate nuisances and businesses. He said you are not putting anything in effect today, you are just setting it by 2/3 vote to where you can explore it at a later time. This gives the County certain powers to regulate nuisances and in businesses, such as adult book stores.

Mayor Morrison called the Commissioners to vote on their keypads. The following vote was taken: Commissioners Bible, Burkey, Clemmer, Cobble, Crawford, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Tucker, and Waddle voted yes. Commissioner Arrowood, Bowers, Bryant, Carpenter, Dabbs, and White voted no. Commissioner Patterson was absent. The vote was 14 – aye; 6 – nay; and 1 – absent. The motion to approve the Resolution passed.

**RESOLUTION TO AUTHORIZE THE EXERCISE BY THE COUNTY OF CERTAIN POWERS GRANTED  
TO MUNICIPALITIES UNDER T.C.A. § 6-2-201(22) AND (23) WITH RESPECT TO THE  
REGULATION OF NUISANCES AND OTHER PRACTICES DETRIMENTAL TO THE INHABITANTS  
OF THE COUNTY**

**WHEREAS**, the General Assembly, in passing Chapter 627 of the Public Acts of 2002 and Chapter 57 of the Public Acts of 2003, amended T.C.A. § 5-1-118 to expand the ability of counties to exercise certain municipal powers in relation to the regulation of nuisances and other practices detrimental to the inhabitants of the county as outlined in T.C.A. § 6-2-201(22) and (23); and,

**WHEREAS**, the Greene County Legislative Body has determined that it would be beneficial to the citizens and residents of Greene County to adopt these regulatory authorities and general police powers; and,

**WHEREAS**, T.C.A. § 5-1-118(c) requires that any county desiring to exercise these powers must adopt a resolution by two-thirds vote of its legislative body in order to do so and must subsequently adopt any such regulations also by a two-thirds majority;

**NOW, THEREFORE BE IT RESOLVED**, by the Greene County Legislative Body, meeting in regular session on this 19th day of February, 2019 at Greeneville, Tennessee, a quorum being present and a two-thirds majority of the Greene County Legislative Body voting in the affirmative that;

**SECTION 1.** Pursuant to the directives of T.C.A. § 5-1-118(c), the Greene County Legislative body, hereby expresses its intent that Greene County be authorized to exercise those powers granted to municipalities under T.C.A. § 6-2-201(22) and (23). Such powers are described by law as the ability to:

- (22) Define, prohibit, abate, suppress, prevent and regulate all acts, practices, conduct, businesses, occupations, callings, trades, uses of property and all other things whatsoever detrimental, or liable to be detrimental, to the health, morals, comfort, safety, convenience or welfare of the inhabitants of the county (only in the unincorporated areas), and exercise general police powers; and
- (23) Prescribe limits within which business occupations and practices liable to be nuisances or detrimental to the health, morals, security or general welfare of the people may lawfully be established, conducted or maintained.

**SECTION 2.** The exercise of such powers by Greene County shall be in accordance with all limitations provided in T.C.A. § 5-1-118. Such authority shall only be exercised in the unincorporated areas of the county. Such authority shall not apply to those activities, businesses or uses of property and business occupations and practices which are exempted from regulation by T.C.A. § 5-1-118(c)(2).

**SECTION 3.** Furthermore, the Greene County Legislative Body recognizes that all court decisions and statutory laws relating to variances and non-conforming uses which are applicable to zoning ordinances and land use controls shall also apply to the enforcement and exercise of the powers granted by T.C.A. § 5-1-118(c). Further, the Greene County Legislative Body recognizes that the enforcement and exercise of these powers by the county is limited by the provisions of the Constitution of the State of Tennessee and the United States Constitution.

**SECTION 4.** Subsequent to the effective date of this resolution, the county is hereafter authorized to adopt regulations in accordance with the authority granted under T.C.A. § 5-1-118(c). In order to be effective, such regulations shall also be passed by a two-thirds majority of the Greene County Legislative Body.

**SECTION 5.** This Resolution shall be effective upon its passage and approval, the public welfare requiring it.

## Powers to Prevent and Abate Nuisances

**Reference Number:** CTAS-563

In 2002, the General Assembly amended a part of the County Powers Act to authorize counties without zoning to exercise the certain regulatory powers granted to municipalities under T.C.A. § 6-2-201(22) and (23). T.C.A. § 5-1-118. The powers are described in the law as the ability to:

- Define, prohibit, abate, suppress, prevent and regulate all acts, practices, conduct, businesses, occupations, callings, trades, uses of property and all other things whatsoever detrimental, or liable to be detrimental, to the health, morals, comfort, safety, convenience or welfare of the inhabitants of the municipality, and exercise general police powers; and
- Prescribe limits within which business occupations and practices liable to be nuisances or detrimental to the health, morals, security or general welfare of the people may lawfully be established, conducted or maintained. T.C.A § 6-2- 201(22) and (23).

The next year, the General Assembly revisited the statute and expanded its application to allow all counties the ability to use these powers after adoption of a local resolution by a two-thirds (2/3) vote of the county legislative body.

Limitations on the Exercise of Regulatory Authority. While this new authority is a broad expansion of county regulatory power, the grant of authority came with several restrictions. The exercise of these powers by counties is limited in a number of ways by both the statute itself and the state and federal constitutions.

## Local Adoption

**Reference Number:** CTAS-564

Even though all counties are eligible to exercise the powers in T.C.A. § 6-2-201(22) and (23), a county may not pass any such regulations pursuant to that authority unless it first adopts those powers by a resolution passed by a two-thirds (2/3) majority of the county legislative body. Also, Chapter 57 of the Public Acts of 2003 clarified that the county must not only pass such a resolution by a two-thirds (2/3) majority but also must pass any subsequent regulations by a two-thirds (2/3) majority. T.C.A. § 5-1- 118.

## Jurisdiction

**Reference Number:** CTAS-565

By law, the authority granted to counties by T.C.A. § 5-1-118(c) may be exercised only in the unincorporated areas of the county. Additionally, the law states that it should not be construed to allow any county to prohibit or in any way impede any municipality in exercising any lawful municipal power or authority.

## Exempted Activities

**Reference Number:** CTAS-566

The law also exempts certain businesses and practices from regulation. The powers conferred upon counties by T.C.A. § 5-1-118(c) do not apply to the following activities, which are regulated under other provisions of general law:

- Sale of beer and alcoholic beverages;
- Wholesale of beer;
- Surface mining; production of oil and gas;
- Activities covered by environmental protection laws and regulations dealing with air pollution, atomic energy, solid waste disposal and management, landfills, hazardous waste management, petroleum underground storage, oil spill cleanup, dry cleaning, water, wastewater and sewerage;
- Water management;
- Wells; and
- Dams.

Additionally, T.C.A. § 5-1-118(b) provides that counties may not use these powers to prohibit or regulate normal agricultural activities.

## Grandfathered Uses

**Reference Number:** CTAS-567

In T.C.A. § 5-1-118(c)(3), the law provides further that all court decisions and statutory laws relating to variances and nonconforming uses applicable to zoning ordinances and land use controls shall apply to the enforcement and exercise of these new regulatory powers. For example, if a county determined that the sound of planes taking off and landing at an airport could potentially be a nuisance to surrounding residential properties and passed a regulation prohibiting the location of an airport within one-half mile of a residential property, this regulation may limit the location of future airports in the county, but an airport that was in existence at the time the regulation was passed that violated the distance rule would be allowed to continue to operate as a pre-existing nonconforming use.

## Constitutional Limitations

**Reference Number:** CTAS-568

As with all government action, regulations passed under this new authority must be both written and enforced in such a manner that they do not violate the constitutional rights of people affected by the regulations. For example, the county could not pass a regulation that prohibited passing out literature of a political nature. This would obviously violate a citizen's First Amendment right to freedom of speech.

The county could not pass regulations prohibiting religious ceremonies or the ownership of guns. The regulations could not discriminate on the basis of race, gender, or other protected classes. These limits are obvious. Issues that are more likely to arise would involve challenges that a regulation resulted in taking property without just compensation or failed to provide due process. If the regulation is so burdensome on a property owner that the owner can no longer get use, enjoyment, or value out of the property, a court may find that the regulation effectively "took" the value of the property from the owner without providing compensation. In that case, the regulation may be struck down, or the county may be required to compensate the injured property owner. Due process problems may arise if citizens are not provided a means to dispute or appeal a penalty under the regulation. Part of providing due process in a regulation also involves giving the public adequate notice of the regulation. This standard of adequate notice requires a regulation to be clear in its language and application so that those affected understand the regulation. If a county regulation is so vague that the public cannot ascertain what conduct is regulated or how it is regulated, it may be struck down as unconstitutional.

## Enforcement

**Reference Number:** CTAS-569

The laws passed in 2002 and 2003 did not include any specific provisions regarding how these new regulatory powers would be enforced. Therefore, enforcement will fall under existing statutory authority. As part of the original "County Powers Act," the legislature passed T.C.A. §§ 5-1-121 and 5-1-123. These statutes authorize enforcement of county regulations by monetary penalties and direct that the general sessions court is the proper venue for enforcement of the regulations. In T.C.A. § 5-1-121, the legislature provided that the penalties for violation could be up to \$500 per violation; however, subsequent court decisions probably place limits on this monetary penalty. See *Chattanooga v. Davis*, 54 S.W.3d 248 (Tenn. 2001). According to the Tennessee Supreme Court in that case, a punitive fine levied by a local government cannot exceed \$50 unless the defendant is allowed to have a jury trial. Higher fines could be enforced if they are remedial in nature rather than punitive, but this distinction is difficult to make. Therefore, a county should generally limit monetary penalties to \$50 or less per violation. Penalty provisions of any regulations should be carefully considered by the county attorney. The county attorney should also be involved in the development of any regulations as he or she will most likely be involved in enforcing the regulations and defending any legal challenges to the regulations. Attorney General's Opinion 03-024 states that ordinances or regulations passed under T.C.A. 5-1-118(c) are to be enforced by a civil lawsuit brought on behalf of the county. The attorney general further opined that since the statutory scheme does not designate a specific officer to prosecute ordinance violations, it appears that suits to enforce a regulation would be brought by the county attorney.

## Other Methods of Enforcement

Reference Number: CTAS-2179

In addition to the authority granted to counties by the County Powers Act, counties may also file suit to abate nuisances pursuant to T.C.A. § 29-3-101 *et seq.* Under this set of statutes, petitions can be brought in the name of the state, upon relation of the attorney general and reporter, or any district attorney general, or any city or county attorney, or without the concurrence of any such officers, upon the relation of ten (10) or more citizens and freeholders of the county wherein such nuisances may exist. T.C.A. § 29-3-102.

The court is authorized to issue a temporary injunction during the proceedings and if the court finds that a nuisance exists at the conclusion of the case, the court will issue an order of abatement. T.C.A. §§ 29-3-105, 110. As part of the order of abatement, the court may assess costs of public services required to abate or manage the nuisance, including, but not limited to, law enforcement costs, if any, caused by the public nuisance. The governmental entity must submit evidence of such costs to the court in order to be reimbursed. T.C.A. § 29-3-110.

**WHEREAS**, in order to incentivize Greene County Sheriff's Department officers to volunteer and work on projects as directed and paid for by the Tennessee Highway Safety Office in addition to working their regular shifts with the Sheriff's Department, it would appear that these officers who volunteer should be paid at the rate of one and one half hours for each hour worked with all funds to pay these officers coming from the grant funding provided by the Tennessee Highway Safety Office

**WHEREAS**, after passage of this resolution and upon approval of the Sheriff, all GCSO officers may be compensated one and one half times their regular rate of pay exclusive of their regularly scheduled 28 day work period while conducting projects and patrols utilizing THSO grant funds.
