The Provisional Counting Board will convene at 4:00 pm on August 6, 2019, at the Election Commission Office located at 218 North Main Street, Greeneville.

PHOTO ID REQUIRED FOR VOTERS

If you are voting in person on Election Day, a federal or State of Tennessee Government issued **photo ID** is required for voting unless an exception applies. College student ID's and out-of-state photo ID's will not be accepted. Forms of acceptable identification, even if expired, include a Tennessee drivers license with your photo, United States passport, Tennessee Department of Safety and Homeland Security photo ID, Photo ID issued by the federal government, United States military ID including a Veteran Identification Card, and a Tennessee handgun carry permit with your photo. Attention Candidates:

Display of campaign posters, signs or other campaign materials, distribution of campaign materials, and solicitation of votes is strictly prohibited within 100 feet of any polling place. (TCA 2-7-111)

During the hours the polls are open, candidates are not to enter a polling place unless they are there to cast their vote. (TCA 2-7-103)
