PROCLAMATION
DECLARING THE WEEK OF FEBRUARY 7-14, 2021
AS CONGENITAL HEART DEFECT AWARENESS WEEK
IN GREENE COUNTY, TENNESSEE

WHEREAS, the health and well-being of congenital heart patients is of paramount importance; and

WHEREAS, each year in the United States, more than 40,000 babies are born with a congenital heart defect; and

WHEREAS, the medical community has identified congenital heart defects as the leading cause of birth defect-related deaths; and

WHEREAS, medical research can provide more identifiable means of the origins and symptoms of congenital heart defects; and

WHEREAS, there is no cure for congenital heart defects, and it is a lifelong disease requiring ongoing specialized care; and

WHEREAS, fewer than 10% of adults with congenital heart disease are receiving recommended care, we must do more to raise awareness for identification, treatment, and lifelong care of congenital heart defects; and

WHEREAS, it is crucial that individuals planning a family, fetal clinicians, obstetric physicians, pediatricians, and all those in the medical field have a greater understanding of the potential for congenital heart defects and assist in educating the greater public about the individual and collective community impact of congenital heart defects; and

WHEREAS, declaring and observing Congenital Heart Defect Awareness Week will also provide a firsthand opportunity for patients and families affected by this condition to share their experiences and knowledge as well as the reminders to all the general public; and

THEREFORE, I, Kevin C. Morrison, Mayor of Greene County, do hereby proclaim February 7-14, 2021, *CONGENITAL HEART DEFECT AWARENESS WEEK* and encourage all to join me in this special observance of education and awareness of this too often subdued lifelong medical condition and its impact on our people and our community.

The Greene County Legislative Body met at the Greene County Courthouse on Monday, January 19, 2021 beginning at 6:00 p.m. The meeting was available for a limited number of in person attendees (50 or less total) with alive Facebook feed broadcast through WGRV and also via ZOOM virtual meeting application for those that could not attend.

Mayor Morrison called the meeting to order to transact business that has lawfully come before the Honorably Body. Commissioner Brad Peters gave the innovation. Commissioner Josh Kesterson led the Pledge to the Flag.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated they were present. Greene County Clerk Lori Bryant recorded and checked off each Commissioner present and those who were absent.

Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Waddle, and White were present. Commissioner Tucker was absent and 1 seat vacant. There were 19 Commissioners present and 1 absent and 1 seat vacant.

RESOLUTION A: A RESOLUTION TO RESCIND THE RESOLUTION
AUTHORIZING THE AMENDMENT TO THE CURRENT BUDGET TO FUND
A FIVE (5%) PERCENT SALARY/WAGE INCREASE FOR ALL EMPLOYEES
(OTHER THAN CONSTITUTIONAL OFFICIALS)

A motion was made by Commissioner Parton and seconded to Commissioner Bryant to rescind the Resolution authorizing the amendment to the current budget to fund a five (5%) percent salary/wage increase for all employees (other than Constitutional Officials).

Voting was conducted by voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote. Commissioner Bryant, Cobble, and Parton voted yes. Commissioners Arrowood, Bible, Bowers, Burkey, Carpenter, Clemmer, Crawford, Dabbs, Kesterson, Peters, Powell, Quillen, Shelton, Waddle, and White voted no. Commissioner Lawing abstained. Commissioner Tucker was and there was one vacant seat. There were 3 – aye; 15 – nay; 1 – abstain; 1 – absent; and 1 – vacant. The motion to rescind the Resolution authorizing the amendment to the current Budget to fund a five (5%) percent salary/wage increase for all employees (other than Constitutional Officials) failed.

ENDING JUNE 30, 2021

Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Waddle, and White vote yes. Commissioner Tucker was absent and there was one vacant seat. There were 19 – aye; 0 – nay; 1 – absent; and 1 – vacant. The motion to approve the Resolution passed.

LEGISLATIVE BODY CREATING A BUDGET CALENDAR

Voting was conducted by voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote. Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Waddle, and White vote yes. Commissioner Tucker was absent and there was one vacant seat. There were 19 – aye; 0 – nay; 1 – absent; and 1 vacant. The motion to approve the Resolution passed.

OTHER BUSINESS

APPOINTMENT OF 7TH DISTRICT COMMISSIONER

Mayor Morrison announced that five individuals had submitted applications to the Greene County Mayor's Office seeking the appointment of the 7th District Commissioner vacated by Commissioner Butch Patterson due to his moving to a residence outside the commission district's boundaries. Submitting applications were April Harmon Lane, Jeffery L Justis, Steven Stout, and Kristin Girton, and Peter Higgins.

Mayor Morrison explained the voting process which a member of the Commission will nominate one of the five qualified candidates, and then we will proceed with a round of voting. The first candidate to receive 11 votes from the majority vote of the Commission will be seated as the new 7th District Commissioner. If none of the receive a majority vote from the first round of voting, the candidate receiving the least amount of votes will drop off and we will proceed to the second round of voting. The voting will continue until one of the candidates receive a majority vote.

April Harmon Lane was the first candidate to speak to the Commission via Zoom. She stated that she works with five budgets in her current position at Tusculum and also concentrated on finances in her previous position. She said, "If elected, I want to help Greene County move in the right direction."

Jeffery L Justis, a retired federal auditor said the reason he applied for the Commissioner position is to support the citizens in the district of the County and help them get the services they need and want without overtaxing them.

Steven Stout told the Commission that he would try to represent the people in his district. "I want to try to make Greene County a better place for our kids and grandkids."

Kristin Girton told the Commission said she wants to be a voice for her community and help learn more about my community and about how she can be helpful, and listen to what the people in her district has to say.

Peter Higgins spoke to the Commission via ZOOM in regards to position of the 7th District Commissioner seat.

Commissioner Bowers nominated Jeffery L. Justis.

Commissioner Crawford nominated Steven Stout.

Commissioner Lawing nominated April Harmon Lane.

Commissioner Peters nominated Kristin Girton.

Commissioner Waddle nominated Peter Higgins.

Mayor Morrison asked three times; "Is there any other nominations."

Mayor Morrison announced that the nominaton cease.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote for the five candidates.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote for the name of their choice for the seat for 7th District Commissioner which was the following: Commissioners Arrowood, Bible, Burkey, Lawing, Powell, Shelton, and White voted for April Harmon Lane. Commissioners Bowers, and Quillen voted for Jeffery L. Justis. Commissioners Bryant, Cobble, Crawford, Dabbs, Kesterson, and Parton voted for Steven Stout. Commissioner Carpenter, Clemmer, and Peters voted for Kristin Girton. Commissioner Waddle voted for Higgins.

There were 7 – votes for April Harmon Lane; 2 – votes for Jeffery L Justis; 6 – votes for Steven Stout; 3 – votes for Girton; and 1 – vote for Higgins; and 1 – absent and 1 – vacant seat. Mayor Morrison stated that Peter Higgins would drop off on round one of voting and the Commission would proceed with round two of voting for April Harmon Lane, Jeffery L. Justis, Steven Stout, and Kristin Girton.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote for their choice for 7th District Commissioner which was the following: Commissioners Arrowood, Bible, Bowers, Burkey, Lawing, Powell, Shelton, Waddle, and White voted for April Harmon Lane. Commissioner Carpenter voted for Jeffery L. Justis. Commissioners Bryant, Cobble, Crawford, Dabbs, Kesterson, Parton, and Quillen voted for Steven Stout. Commissioners Clemmer and Peters voted for Kristin Girton. Commissioner Tucker was absent and there was one vacant seat. There were 9 – votes for April Harmon Lane; 1 – vote for Jeffery L. Justis; 7 – Steven Stout; and 2 – vote for Kristin Girton; and 1 – absent; and 1 – vacant seat. Mayor Morrison stated that Jeffery L. Justis would drop off on round two of voting and the Commission would proceed with round three of voting for April Harmon Lane, Steven Stout, and Kristin Girton.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote for the name and stated their vote for their choice for 7th District Commissioner which was the following: Commissioners Arrowood, Bible, Burkey, Lawing, Peters, Powell, Shelton, Waddle, and White vote for April Harmon Lane. Commissioners Bowers, Bryant, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Parton, and Quillen voted for

Steven Stout. There were no votes for Kristin Girton on the third round of voting.

Commissioner Tucker was absent and there was one vacant seat. There were 9 – votes for April Harmon Lane; 10 – votes for Steven Stout; and 0 – vote for Kristin Girton; 1 – absent; and 1 – vacant. Mayor Morrison stated Kristin Girton would drop off of round three of voting and the Commission would proceed with round four of voting for April Harmon Land and Steven Stout.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote for the name and stated their vote for their choice for 7th District Commissioner which was the following: Commissioners Arrowood, Bible, Burkey, Lawing, Peters, Powell, Shelton, Waddle, and White voted for April Harmon Lane. Commissioners Bowers, Bryant, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Parton, and Quillen voted for Steven Stout. Commissioner Tucker was absent and there was one vacant seat. There were 9 – votes for April Harmon Lane; 10 – votes for Steven Stout; 1 – absent; and 1 – vacant seat.

County Attorney Roger Woolsey explained that the Commission could continue to vote or postpone the action until the next meeting when hopefully all 20 members would be in attendance and the Mayor could vote if there was a tie.

A motion was made by Commissioner Bryant and seconded by Commissioner Powell to cease all nominations and restrict to the consideration to the two candidates that is already deadlocked, and voting would be postponed until the next Commission Meeting, which will be Tuesday, February, 16, 2021.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote. Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Lawing, Parton, Peters, Powell, Quillen, Shelton, Waddle, and White voted yes. Commissioner Tucker was absent and there was one vacant seat. There was 19 – aye; 0 – nay; 1 – absent; and 1 –vacant seat. The motion to cease all nominations and restrict to the consideration to the two candidates that is already deadlocked, with voting to be postponed until the next Commission meeting, which will be Tuesday, February, 16, 2021 passed.

Commissioner Bryant asked County Attorney Roger Woolsey about the communication between Commissioners to relate what they may know about the candidates. Roger Woolsey explained to the Commissioners that they could speak individually to the two candidates; however, state laws restricts any communications between Commissioners regarding governmental decisions outside a meeting.

OTHER BUSINESS

APPOINTMENT OF COMMISSIONER TEDDY LAWING TO THE GREENEVILLE/GREENE COUNTY LIBRARY BOARD

A motion was made by Commissioner Shelton and seconded by Commissioner Bowers to the appointment of Commissioner Teddy Lawing to the Greeneville/Greene County Library Board.

Voting was conducted by individual voice vote. Mayor Morrison called each Commissioner by name in alphabetical order, and each Commissioner stated their name and stated their vote. Commissioners Arrowood, Bible, Bowers, Bryant, Burkey, Carpenter, Clemmer, Cobble, Crawford, Dabbs, Kesterson, Parton, Peters, Powell, Quillen, Shelton, Waddle, and White voted yes. Commissioner Lawing abstained. Commissioner Tucker was absent and there was one vacant seat. There were 18 – aye; 0 – nay; 1 – abstain; 1 – absent; and 1 – vacant seat. The motion to the appointment of Teddy Lawing to the Greeneville/Greene County Library Board passed.

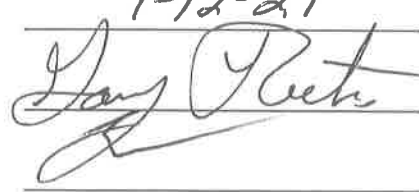

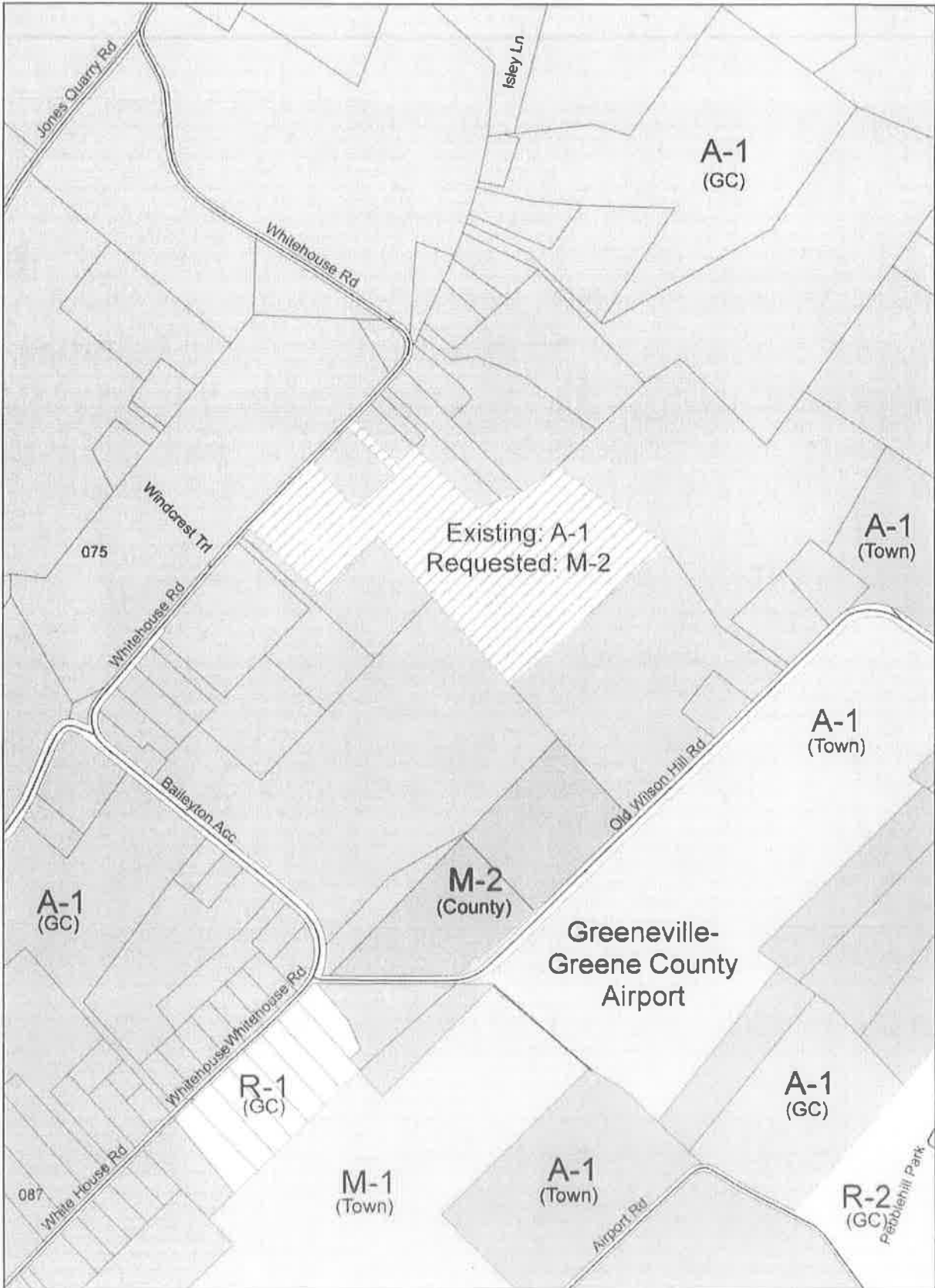

Administrative approval was granted to the preliminary and final plat for the division and recombination of two (2) parcels at 102 Montford Avenue and 400 North Main Street, as identified on Greene County Tax Map 098E, Group C, Parcel 040.01 and 037.01 as requested by Cornerstone Land Surveying P.A. on behalf of property owner. The property is located within the Town of Greeneville's corporate limits and is zoned R-1 (Low

Density Residential). The purpose of the survey is to accommodate the intentions of the property owners to transfer areas of property between adjoining owners to better facilitate the use of their properties. The plat met all subdivision regulation requirements of the Town of Greeneville as well as all applicable zoning ordinance regulations. Staff recommended consent.

2585 Whitehouse Road, preliminary and final plat for the subdivision and recombination of two (2) parcels, Mays and Laughter's Property, Bowman Land Surveying. Administrative approval was granted to the preliminary and final plat for the division of 0.11 acres from Greene County Tax Map 075, Parcel 045.00 to be combined with Greene County Tax Map 075, Parcel 050.00, property located at 2585 Whitehouse Road as requested by Bowman Land Surveying on behalf of the property owners. The property is located within the Town of Greeneville's Urban Growth Boundardy. The purpose of the survey is to transfer a parcel of land being 0.11 acres in size between adjoining owners to better facilitate the use of Parcel 050.00. The plat has been reviewed and approved for zoning requirements by the Greene County Planning Department. The plat met all subdivision regulation requirements of the Town of Greeneville. Staff recommended consent.

Oak Grove Road and New Hope Road, recommendation to the Board of Mayor and Aldermen to rezone approximately 500 feet northwest of the intersection from R-1 (Low Density Residential) to R-SF2 (Low Density Residential). Motion was made, seconded and carried to recommend to the Board of Mayor and Aldermen that property located on the west side of Oak Grove Road and being approximately 500 feet northwest of the intersection of Oak Grove Road and New Hope Road, as identified on Greene County Tax Map 099, Parcel 011.04 be rezoned from R-1 (Low Density Residential) to R-SF2 (Low Density Residential). A rezoning sign was placed on the property and staff notified affected adjacent and in the vicinity of property owners via letter. The request is to apply an overlay zoning district of R-SF2 (Low Density Residential) to a property currently zoned R-1 (Low Density Residential). The rezoning request for this parcel has been submitted by the current property owners. The rezoning request was initiated to allow development of the property as single family residential under the guidelines of the R-SF2 overlay. The use of the property would remain the same (single family residential only). The overlay district of R-SF2 (Low Density Residential) would allow for denser development with the minimum lot size being reduced to 7,500 sq. ft. and a minimum lot width being reduced to 50 feet. Front and rear setbacks would remain the same as R-1 (30 feet front and 30 feet rear) but the side yard setback would be reduced to 8 feet. As a comparison example, Phase 2 of the Villas at the Meadows on Villa Lane has been developed under the same zoning overlay classification. Staff recommended that the Greeneville Regional Planning Commission grant approval and recommend the rezoning request from R-1 (Low Density Residential) to R-SF2 (Low Density Residential) to the Greeneville Board of Mayor and Aldermen for their approval.

1265 Jones Bridge Road, preliminary and final plat, relocation of the divisional line between Lot 5R and Lot 4R, Edward Wills Property, Azimuth Engineering, Inc. Administrative approval was granted to the preliminary and final plat for the relocation of a portion of the divisional line between Lot 5R and Lot 4R, as identified on Greene county Tax Map 111, Parcels 002.04 and 002.05 as requested by Azimuth Engineering, Inc. on behalf of property owner. The property is located within the Town of Greeneville's Urban Growth Boundary. The purpose of the survey is to relocate a portion of the divisional line to provide the required setback for an existing structure located on Lot 4R. The plat has been reviewed and approved for zoning requirements by the Greene County Planning Department. The plat met all subdivision regulation requirements of the Town of Greeneville. Staff recommended consent.

Recommendation to deny request to rezone property located on Whitehouse Road near the northwesterly end of the Greeneville Municipal Airport from A-1 (Agriculture) to M-2 Manufacturing) Urban Growth Boundary, denied. Motion was made, seconded, and carried to make a recommendation to the Greene County Commission to not rezone property located on Whitehouse Road near the northwesterly end of the Greeneville Municipal Airport as identified on Greene County Tax Map 075, Parcel 051.06 from current county zoning A-1 (Agriculture) to county M-2 (Manufacturing). A rezoning sign was placed on the property and staff notified all affected adjacent and in the vicinity of property owners via letter. The property is located within the Town of Greeneville's Urban Growth Boundary. Staff recommended that due to the following factors, the recommendation of the Greeneville Planning and Building Department is to not recommend the rezoning request: 1) No use for the property with the requested M-2 zoning has been identified. 2) The property does not adjoin any other properties that are currently zoned M-2. 3) Due to the proximity of the property to the airport, a use of the property with the requested M-2 zoning could be detrimental to the future use of the airport.

The property is located within the Town of Greeneville's Urban Growth Boundary.

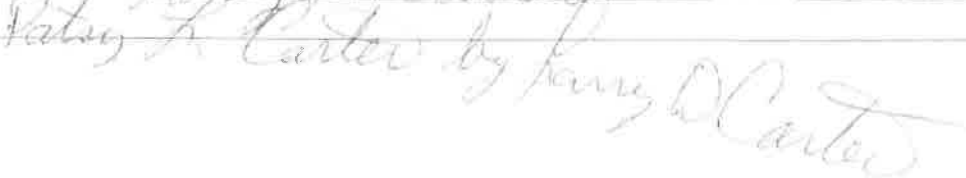

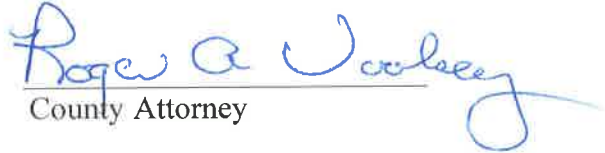
