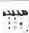

Greene County Mayor Morrison announced that the Proclamation for the Rheatown Community & Rheatown Store had been previously presented on November 29, 2025.

PREVIOUSLY PRESENTED – DECEMBER 5, 2025 – A PROCLAMATION FOR THE INAUGURATION OF THE 2025 CHRISTMAS SEASON IN THE TOWN OF GREENEVILLE AND THROUGHOUT GREENE COUNTY

Greene County Mayor Morrison announced that the Proclamation for The Inauguration of the 2025 Christmas Season in the Town of Greeneville and throughout Greene County had been previously presented on December 5, 2025.

A PROCLAMATION FOR TRAFFICKING AWARENESS MONTH – JANUARY 2026

Mayor Morrison read the Proclamation for Human Trafficking Awareness Month. I, Kevin C. Morrison, by virtue of the authority vested in me as Mayor of Greene County, Tennessee, do hereby proclaim the month of January 2026 as Human Trafficking Awareness Month aligning with the State of Tennessee and community partners across the state to remember the victims and survivors of this crime and further our commitment to ending human trafficking in communities across the state and nation.

Mayor Morrison presented the Proclamation to Gracie Delaney.

FOR THE GREATER GOOD

Mayor Morrison announced that will be a Special Food Distribution on December 18th at 3 p.m. – 5 p.m. from Second Harvest Food Bank.

PUBLIC HEARING

Commissioner Waddle called on Retired U.S. Army Lt. Col. John Cox to speak to the Commission in regards to expanding the Andrew Johnson National Cemetery in Greeneville, which has been closed to new burials since 2019.

Lt.Col. John Cox urged passage of the Resolution J. Consideration of A Resolution of the Greene County Commission Encouraging Federal and State Legislative Action to Expand the Andrew Johnson National Cemetery, stating that when his brother, a veteran, died two years ago, their family wanted to bury him at the Greeneville Cemetery, where their father is buried, but were unable to. He suggested the 25 acres of land on East Vann Road near the Greene County Veterans Memorial Park currently owned by Ballad Health would be a good site to expand the cemetery.

Commissioner Bowers called on Milton Parman, a former County Commissioner, U.S. Army Veteran and retired educator, who suggested two courses of action: Approval of Resolution J and the formation of a committee with members of veterans groups and others who will take the resolution to Nashville and elected representatives in Washington, D.C.

Greene County Mayor Morrison called Grady Barefield, who is currently the American Legion Post 64 Chaplain in Greeneville to speak in favor of expanding the Cemetery. Mayor Morrison stated that Grady Barefield, an enthusiastic advocate, for an effort undertaken about six years ago to expand the cemetery, collected first 5,700 names and then another 800 for a petition in favor of such action. At that time, the feedback wasn't very favorable.

Commissioner Dabbs called on Mrs. Rasnake to speak in regards to the property on Jim Fox Road. She said in May 2022, a resident, Judith Wallace filed a petition with code enforcement in regards to property on Jim Fox Road. At that time, the property was looked at the next day and Greene County Building Zoning Director, Tim Tweed did find the property in violation. Mrs. Rasnake said she had filed the same complaint on February 2025 for the same reason and nothing has been done about the property owner cleaning up his property.

County Attorney Roger Woolsey stated that he had explained to Mrs. Rasnake that the property would be cleaned up as soon as the contractor was available to clean it up. The property owner had been making threats that if anyone came on his property he would shoot them. County Attorney Roger Woolsey said that the contractor would be out there the week of the December 15th to clean it up.

- G. A resolution authorizing the Greeneville/Greene County EMS to donate a used school bus to the Emergency Chaplains of Tennessee. Motion to approve resolution G was made by Commissioner Burkey and was seconded by Commissioner Smithson. All were in favor.**

DISCUSSIONS:

Attorney Woolsey discussed the fact that since the Planning Commission & Building & Zoning had moved out, and 911 was the only ones remaining, it was time to move forward to issue settlement for them to have the whole building along with the responsibilities of taking care of the building itself. A motion to add a resolution to issue settlement for 911 to take over the whole building was made by Commissioner Burkey and seconded by Commissioner Smithson. All were in favor.

EMS Director TJ Manis told the Budget & Finance Committee that he had received an official estimate for the Baileyton EMS Station Fire damage by the adjuster. There was \$35,000 worth of damage.

Road Superintendent Kevin Swatsell is requesting to sell a used truck on GOVDEALS. Attorney Woolsey said he would need to send information to his office to prepare a resolution. A motion was made by Commissioner Smithson to declare County owned property surplus, obsolete, or unusable pursuant to T.C.A. § 5-14-108 Highway's Department. It was seconded by Commissioner Peters. All were in favor.

Greene County Health Director Jaime Hensley told the Committee the new Health Department looking very good and plans were to be finished by June 2026.

Mayor Morrison gave an update on the Snapps Ferry project. It is finishing up and the development is going to be very beneficial for the Community.

The next regular scheduled Budget & Finance Committee meeting will be on Wednesday, January 7th, 8:30 A.M. Held in the Greene County Annex Conference Room, Greeneville, Tennessee.

Call to Order:

Mayor Morrison called meeting to order in the conference room at the Greene County Annex. Quorum was present.

Minutes:

Motion was made by Commissioner Crawford and was seconded by Sheriff Holt to approve the minutes from October 22, 2025. Motion was approved with no opposition.

Reports:

Clinic – Leslie Jones gave the clinic reports for October 2025. There were 333 patients, 35 more than last year. Of the 333 visits, there were 146 provider visits and 187 nurse visits. There were 8 no shows. Leslie stated there were 53 biometric physicals. Leslie stated sick visits have been up. Sheriff Holt stated that he couldn't brag enough on the clinic since we have gone this route and he has not had any complaints about the clinic from his department. Attorney Woolsey stated he still gets calls about how it's running and calls from other government entities asking if we should be running the clinic. Mayor stated there are three of us here that were here in 2002 sitting at this table wondering how we were going to pay for insurance without raising premiums and with no money to do anything and certainly no clinic and now to come in here and have a clinic report and financial report and know we are running smoothly for the most part and we are operating nominally with good coverage and people happy. Mayor went on to say that insurance has dramatically improved and the benefits to our employees is nothing short of unbelievable when you start comparing it to other places.

Financial - Danny Lowery emailed the financial reports with notes for October 2025 to the Insurance Committee on November 21, 2025. In Danny's absence, the Mayor asked if anyone had any questions about the financial report? Mayor stated from Danny's notes it looks like the cash with the Trustee is static and Fund 121 is down a little bit with us absorbing a little bit of premium increase and payments for Hurricane Helene. Mayor also stated to keep in mind that we have increased capital ownership of equipment. Attorney Woolsey asked that some of the funds we've spent will come back to us through FEMA, we hope, correct? Mayor, agreed, yes it will. Mayor stated that they're responsible for 75% of what they have approved but to date we haven't received any money from the federal government. Mayor stated he went last week to Meadowview to a TDEC grant conference, which was mandatory to attend by TDEC, because they were making

money available through grants to all of the counties affected by Hurricane Helene. Mayor stated that some of the bigger, better off financially counties like Washington and Sullivan were okay, with Greene being in the middle but Unicoi County's undesignated fund balance is only 900k. Mayor stated that Carter County and Johnson County were in somewhat similar situations. Mayor stated that the reimbursement grants are taking way too long to get back. Mayor stated he doesn't have any confidence in the money that the state has made available for interest and admin costs for anything borrowed for three years.

A motion to approve the financial reports was made by Chris Malone, Greene County School Director. Motion was seconded by County Attorney Woolsey. Reports were approved with no opposition.

Other Business.

Mayor stated the Insurance Committee Meeting for December needs to be rescheduled due to the Christmas Holiday. After discussion amongst the committee, it was decided to move the December Insurance Committee Meeting to Tuesday, December 23rd @ 8:30 a.m.

Chris Poynter stated Sheriff Holt reached out to him concerning one of his employees and Delta Dental's 180 day waiting period for some services. So, Chris went to Delta Dental and they will remove that 180 day waiting period on all plans and it will be retro-active back to 7-1-2025, with no rate change. Anyone that had any issue since 7-1-2025 will get their claims re-processed. Mayor and others thanked Chris for getting that changed.

Sheriff stated that there is a 1000-gallon diesel fuel tank underground (in the back parking lot) at the jail which has been compromised and has water in the diesel fuel. Sheriff said they discovered over the last 2 weeks the generator won't kick on like it's suppose to. They have remedied that by getting a 300-gallon tank to fuel the generator. However, the Sheriff stated that they will probably need to pump the contaminated fuel out of the tank along with some algae. Sheriff stated the tank was probably put in around 1985-86. Mayor asked if the Sheriff knew if the tank was metal or fiberglass and the Sheriff does not know. Sheriff stated that would be a Dave Wright question. The Sheriff thinks the fuel will have to be pumped out first and then removed. Mayor stated that there was a 6000-gallon tank underground in the back parking lot of the hospital (which was installed in 1991) that had to be removed and it had almost 5500 gallons of fuel in it and that tank was fiberglass. Mayor stated that the contractor had to come over to remove it. Sheriff does not think anything is leaking out but just water is leaking into the tank. Commissioner Dabbs asked if the fuel could be moved to another tank? Sheriff stated since it's contaminated, he wasn't sure what they would have to do with it. Mayor stated the tank at the hospital they had Jimmy Windfield to come in and remove and dispose of the fuel from that tank and there was a cost per gallon. Commissioner Peters suggested to call Johnson Petroleum because when he worked at public works Johnson Petroleum had equipment that would filter out the water from the fuel. Mayor stated that he could contact Mark at Greeneville Oil to inquire if they have the capabilities to separate the water from the fuel. Mayor asked the Sheriff if he knows if we have an underground

certificate on that? The Sheriff does not know and Mayor states that's where TDEC would get involved.

Commissioner Peters asked Chris what his take was on all the ACA stuff with the federal government? He stated the individual plans have gone up 40-50% and will become unbearable for people. The individual market is a mess. Chris said if he had a friend that needed insurance and they were healthy, he would tell them to contact Farm Bureau, their plans are not ACA compliant because they can underwrite. There was continued discussion by the committee members about ACA, other insurance, clinic, etc.

Leslie stated that she and Danae have everything set up for January to start doing the comparisons with the dummy claims with BCBS. Leslie stated she still has to get Melissa set up to do hers but Kara is set up and ready.

Motion to adjourn and go into closed session was made by Sheriff Holt. There was no opposition.

Claims:

Motion was made by Commissioner Dabbs and seconded by Commissioner Crawford to approve Claim TSC-0002694. Claim was approved with no opposition.

DISCUSSION:

Dave Wright updated the Committee, the Core Drilling was completed, and it came back with results that were better than anticipated. We will be keeping the prisoner toilet, and everything will be ADA compliant and have concrete floors. Wright estimates the construction to take approximately 8 months. Once completed the majority of toilets in the courthouse will be decommissioned.

Whitney Collins is making sure the new plans meet the judicial system standards for restroom facilities.

Mayor Morrison stated that all records except those that belong to the Circuit Court Clerk will be moved to the new Greene County Government Center for storage.

Wright told the committee the work to repair the front portico of the courthouse, a portion of which is closed due to damage, will begin December 1st and should take about two weeks to complete. During that time those entering the courthouse will do so via the handicap access path. Funding for that improvement will come from a \$500,000 state grant. Those monies cannot be used for the construction of the new addition, but the mayor says the estimated \$1.3 million price tag could be paid through general debt service, without impacting the county tax rate.

Brad Peters asked about next step. The response was to move the utilities. Dave Wright said moving utilities, electricity, water, and gas lines will be costly but does not yet have a dollar estimate.

Whitney Collins stated the if we don't do the remodel, we cannot use the Courthouse. The bathroom situation has to be resolved. Damp, cold weather makes the sewer smell worse.

Dave Wright said a new justice center would cost an estimated \$120 million.

Mayor Morrison and Dave Wright want to have another conversation with Scott Niswonger about the of the former bank building he owns next door to the courthouse.

The committee will meet again to formulate a more detailed plan for presentation to the full County Commission to consider prior to it being put out for bids.

Whitney Collins requested that the time of next meeting be adjusted to accommodate some of the judge's schedules so they could attend.

There was no new business to address.

A motion to adjourn the meeting was made by Teddy Lawing and seconded by Nick Gunter. Vote to adjourn the meeting was unanimous.

WHEREAS, existing regulations require under 501.5 Owners of all properties that have access to a public road only by right-of-way or easement, may be issued one (1) building permit provided the subject property was subdivided into this state prior to the effective date of the Zoning Resolution of Greene County, Tennessee.

WHEREAS, the Office of Inspection and Regulation receive several inquiries per week related to properties that have insufficient road frontage, which result in denial of building permits for large tracts of property within Greene County; and

WHEREAS, several citizens have publicly and privately questioned the provisions of the Greene County Zoning Resolution related to road frontage, desiring that the Greene County Legislative Body on October 20, 2025, create a committee to study solving road frontage requirement issues for parcels in Greene County that otherwise do not have road frontage sufficient to enable the owner(s) to secure a building permit under the current requirements of the County's Zoning Ordinance; and

**RESOLUTION REQUESTING THE 114TH SESSION OF THE TENNESSEE
GENERAL ASSEMBLY TO ALLOCATE ONE HALF OF THE REAL
ESTATE TRANSFER TAX COLLECTED PURSUANT TO T.C.A. 67-4-409
TO THE COUNTY WHERE THE TAX WAS COLLECTED ON A
RECURRING BASIS**

WHEREAS, for many years, pursuant to T.C.A. 67-4-409, the State of Tennessee has imposed a privilege tax of \$0.37 per \$100 of value of the realty transferred for the privilege of publicly recording documents evidencing all transfers of realty, whether by deed, court deed, decree, partition deed, or other instrument evidencing transfer of any interest in real estate; and

WHEREAS, although this tax is collected locally, 95% of the privilege tax collected locally is remitted to the State of Tennessee and individual counties are only able to retain 5% of the privilege tax collected for collecting and reporting taxes levied under the law; very little of the revenue collected is available for use by local officials to address needs in the community where the tax is collected; and

WHEREAS, county governments have few revenue options available to them for funding the many crucial governmental services mandated by state law and are therefore largely dependent upon property tax to fund these services; and

WHEREAS, county governments have been fiscally disciplined, allowing Tennessee to remain a low property tax burden state; however, county budgets are increasingly strained by factors such as inflation, challenges in recruiting and retaining qualified staff, and requirements to meet State mandates like increasing teacher compensation; and

WHEREAS, Greene County as well as other counties are experiencing rapid population growth as families are choosing to move to Tennessee and settle in its communities, adding to the demand for county services and infrastructure which are necessary to maintain the quality of life all Tennesseans expect and deserve; and

WHEREAS, as the State of Tennessee continues to experience revenue collections in excess of budgeted estimates, allocating one half of the real estate transfer tax on a recurring basis to the county where collected would take pressure off the necessity of increasing local property taxes and allow for investment in infrastructure and services without unduly burdening State of Tennessee finances and without increasing the rate of this privilege tax.

NOW, THEREFORE BE IT RESOLVED by the Greene County Legislative Body meeting in regular session this 20th day of January, a quorum being present does hereby request that the Tennessee General Assembly amend Tennessee Code Annotated 67-4-409 to direct that one half of the privilege tax collected pursuant to Tennessee Code Annotated 67-4-409 be equally shared with the County where collected on a recurring basis.

AND BE IT FURTHER RESOLVED, that upon passage and signage, the County Clerk shall forward a copy of this Resolution to State Senator Steve Southerland and State Representative David Hawk, members of the Tennessee General Assembly representing Greene County, Tennessee, Cameron Sexton, Speaker of the State House, Randy McNally, Lieutenant Governor and Speaker of the Tennessee Senate, and Governor Bill Lee.

**RESOLUTION AUTHORIZING THE COUNTY MAYOR TO ENTER
INTO A GOOD NEIGHBOR AGREEMENT BETWEEN GREENE
COUNTY AND THE UNITED STATES DEPARTMENT OF
AGRICULTURE FOREST SERVICE, CHEROKEE NATIONAL FOREST**

WHEREAS, to regenerate and restore areas severely damaged by the aftermath of Hurricane Helene the federal government established a Good Neighbor Agreement funded through the Explore Act of 2025 which supports the restoration of and improvement of recreational facilities and areas within national forests including those areas located in Greene County, Tennessee within the Cherokee National Forrest. The local project is designed to ensure safe and reliable access to recreation areas while restoring a critical part of Greene County's outdoor recreation economy. Outcomes would benefit both public safety and the local economy by enhancing safety, expanding tourism, and supporting local businesses who rely on recreation-based tourism; and

WHEREAS, Greene County, Tennessee serves as gateway to Cherokee National Forest, offering extensive hiking, biking, horseback trails, trout streams, camping, picnicking, scenic thoroughfares, and Appalachian Trail Access which in turn is an important component of the county's economy; and

WHEREAS, the Good Neighbor Agreement would facilitate a working relationship between Greene County and the United States Department of Agriculture Forest Service, Cherokee National Forest to facilitate the rebuilding and restoring of portions of the Cherokee National Forest that the economy of Greene County depends on for tourism and recreational activities. The United States Department of Agriculture provides funding for all projects through the Explore Act of 2025 with no matching county funds required. Greene County in coordination with the Cherokee National Forest staff would serve as the lead in securing bids for necessary work, managing contracts, maintaining communication at platforms for public

updates, and business coordination and overall supervising the various projects through completion; and

WHEREAS, this resolution authorizes the basic framework for Greene County and the United States Department of Agriculture Forest Service, Cherokee National Forest to cooperate and formulate plans but does not actually commit Greene County to perform any work on the various projects without the approval of both the Greene County Legislative Body and the United States Department of Agriculture Forest Service, Cherokee National Forest.

NOW, THEREFORE, BE IT RESOLVED, by the Greene County Legislative Body meeting in regular session on the 20th day of January, 2026, a quorum being present and a majority voting in the affirmative, to authorize the County Mayor to enter into and execute a Good Neighbor Agreement with the United States Department of Agriculture concerning the rebuilding and restoration efforts in the Cherokee National Forest.
