

# GREENE COUNTY ELECTION NOTICE

**August 6, 2026, State / Federal Primary, County General, Town of Baileyton Municipal, Town of Greeneville Municipal, and the Town of Mosheim Municipal Election**

**To the voters of Greene County, TN,** notice is hereby given, pursuant to TCA 2-12-111(a), that a State / Federal Primary and a County General Election will be held on Thursday, August 6, 2026, in all voting precincts in Greene County, TN. Additionally, municipal elections will be held for the Town of Baileyton, Town of Greeneville, and the Town of Mosheim on Thursday, August 6, 2026, for voters within these municipalities.

## **Town of Baileyton Municipal Election**

Alderman ( <i>two seats</i> )	4-year term
Any other office or question that may timely qualify to appear on the ballot	

## **Town of Greeneville Municipal Election**

Council Member- Ward 1 ( <i>two seats</i> )	4-year term
Water Commissioner ( <i>one seat</i> )	6-year term
Any other office or question that may timely qualify to appear on the ballot	

## **Town of Mosheim Municipal Election**

Alderman ( <i>two seats</i> )	4-year term
Any other office or question that may timely qualify to appear on the ballot	

- The first day to pick up a nominating petition is **Friday, January 9, 2026**.
  - *This applies to primary and independent candidates for the offices on the August primary ballot and non-partisan municipal candidates in the Town of Baileyton, Town of Greeneville, and the Town of Mosheim.*
- The qualifying deadline is **Tuesday, March 10, 2026, at 12:00 Noon**.
  - *This deadline applies to primary and independent candidates for the offices on the August primary ballot and non-partisan municipal candidates in the Town of Baileyton, Town of Greeneville, and the Town of Mosheim Municipal Election.*
- The withdrawal deadline is **Tuesday, March 17, 2026, at 12:00 Noon**
- Each independent or primary candidate for an office elected by the voters of the entire state and each independent or primary candidate for the office of representative to the United States congress shall file the candidate's original nominating petition in the office of the state election commission, a certified duplicate with the Coordinator of Elections and with the chair of the party's state executive committee in the case of primary candidates by **Tuesday, March 10, 2026, at 12:00 Noon**.
- Each independent or primary candidate, other than for an office elected by the voters of the entire state or candidates for the office of representative to the United States congress, shall file the candidate's original nominating petition in the county in which the candidate is a resident and shall file certified duplicates of the nominating petition in all other counties wholly or partially within the area served by the office which the candidates seek by **Tuesday, March 10, 2026, at 12:00 Noon**.
- The last day to register to vote in person or by mail postmark for the August 6, 2026, Election is **Tuesday, July 7, 2026**.

## **County General Election & the Town of Greeneville Municipal School Board Election**

*Nominees from the May 5, 2026, County Primary Election as well as independent candidates for all county offices in which a county primary was called will also appear on the August 6, 2026, County General Election ballot.*

*Additionally, nominees from the May 5, 2026, Town of Greeneville Municipal School Board Primary Election as well as independent candidates for Town of Greeneville Municipal School Board will appear on the August 6, 2026, Town of Greeneville Municipal Election ballot. The qualifying deadline for these offices is Thursday, February 19, 2026, at 12:00 Noon.*

## **Public Notice for Elderly Voters or Voters with Disabilities**

Any elderly voter or voter with a disability whose polling place is inaccessible may vote early by absentee ballot *or* at the Election Commission Office on Election Day. If voters choose to vote at the Election Commission Office on Election Day, they must complete an affidavit at the Election Commission Office **no later than July 27, 2026**, (ten days prior to the election), stating that their designated voting location is not accessible. For more information, please contact the Greene County Election Commission office.

**PHOTO ID REQUIRED FOR VOTERS:** If you are voting in person during Early Voting or on Election Day, a Federal or State of Tennessee Government issued **photo ID** is required for voting, unless an exception applies. College student ID's and out-of-state photo ID's will not be accepted. Forms of acceptable identification, even if expired, include a Tennessee driver license with your photo, United States passport, Tennessee Department of Safety and Homeland Security photo ID, Photo ID issued by the federal government, United States military ID including a Veteran Identification Card, and a Tennessee handgun carry permit with your photo.
